THE FOLLOWING IS AN OUTLINE FOR OBTAINING A NEW JERSEY FIREARMS I.D. CARD, PISTOL PURCHASE PERMIT.

1: FOR N.J. FIREARMS I.D CARD

A. FILL OUT APPLICATION **ANSWERING ALL QUESTIONS TRUTHFULLY** AND CHECK OFF FIREARMS ID CARD ON TOP OF APPLICATION.

B. FILL OUT MENTAL HEALTH FORM AND SIGN SAME. **WITNESS LINE TO BE SIGNED BY A POLICE OFFICER WHEN APPLICATION IS RETURNED.**

C. APPLICANT MUST BE FINGERPRINTED. (STATE & FEDERAL) BY STATE POLICE VENDOR MORPHOTRAK.

D. **\$5.00 CASH FOR APPLICATION. FEE FOR FINGERPRINTS IS \$60.25 PAID DIRECTLY TO VENDOR.**

2: PISTOL PURCHASE PERMIT

A. MUST HAVE A FIREARMS I.D. CARD AND BE 21 YEARS OLD

B. FILL OUT APPLICATION **ANSWERING ALL QUESTIONS TRUTHFULLY** AND CHECK OFF PISTOL PURCHASE PERMIT WITH NUMBER OF PERMITS REQUESTED.

C. FILL OUT MENTAL HEALTH FORM AND SIGN SAME. **WITNESS LINE TO BE SIGNED BY THIS OFFICER WHEN APPLICATION IS RETURNED.**

D. \$2.00 CASH FOR EACH PERMIT REQUESTED. EXAMPLE IF REQUESTING TWO PERMITS IT WOULD BE \$4.00

E. IF A PARTY IS REQUESTING BOTH A FIREARMS I.D. CARD & PISTOL PURCHASE PERMIT IT WOULD BE \$7.00 CASH.

F. IF PARTY HAS ID CARD AND NEEDS A PISTOL PURCHASE PERMIT A MONEY ORDER FOR \$18.00 MADE OUT TO "NJ STATE POLICE SBI" IS NEEDED ALONG WITH FORM SBI(212A) ****SEE ME FOR FORM.****

3: FOR CONCEALED OR HANDGUN CARRY PERMITS APPLICANTS MUST SEE ME.

RELATIVES MAY NOT BE USED AS A REFERENCE / ALL APPLICATIONS MUST BE PROPERLY FILLED OUT AND COMPLETELY LEGIBLE OR THEY WILL BE RETURNED WITHOUT BEING PROCESSED. ALL FORMS ARE AVAILABLE AT WWW.NJSP.ORG UNDER SERVICES(FIREARM FORMS) THESE ARE PDF FILES AND CAN BE TYPED IN AND THEN PRINTED OUT(PREFERED).
